### 2023 Travel Reduction Survey is here!

Complete the survey by March 10 to be entered into a gift card drawing

The State and other large employers are required by law to survey annually all of their employees working in Maricopa County at least three days per week for no less than six months per year. Interns, temporary workers and contractors should not take the survey. You should have received the survey link via email.

Your participation in this survey is critical! This survey information has provided us the data to secure transit subsidies, provide input on bus routes, and make suggestions for the light rail system.

New this year: The travel reduction survey is now hosted on the Capitol Rideshare RideAmigos transportation demand management (TDM) platform and provides a much improved user experience. This is the same platform that hosts the Commuter Club, monthly contest drawings, the Emergency Ride Home (ERH) program and the ride-matching service. For employees who have been using these services, the survey interface will have a familiar feel..

Telecommuting: you must fill out the survey if you are telecommuting or working in virtual office status. Please fill out the survey according to the schedule you are currently working. Question #3 asks about your commute. If you are telecommuting one or more days per week, choose the corresponding number of days you are currently telecommuting. If you are only working remotely and not driving into the office, use the number of miles you previously drove to the agency work site when asked for your commute miles in question #6 and estimated time from your home to the agency work site, even if you are not currently driving. If you were hired as a virtual worker, please select the main agency headquarters address. Items #8 – #12 on the Frequently Asked Questions (FAQs) page explains how and why telecommuters must complete the survey.

Gift card drawing: Capitol Rideshare has added an incentive for employees to complete the survey. All employees who complete the survey by March 10 will be opted into a drawing for a \$25 gift card with a winner chosen at random. If you do not want to be entered into the survey, please be sure to click the button to opt out.

# Vehicle Emissions Inspection Program 2023 Notice to Employees

#### BACKGROUND:

To improve air quality and reduce vehicle emissions in heavily traveled areas, the Arizona Department of Environmental Quality (ADEQ) administers a mandatory vehicle emissions inspection program known as the Vehicle Emissions Inspection Program (VEIP).

Arizona law (A.R.S. §49-542) requires vehicle emission inspection and testing for:

- Most vehicles registered in the Area A vehicle emissions control area of greater metro Phoenix (including parts of Maricopa County and parts of Pinal County and Yavapai County as defined by A.R.S. §49-541) and/or
- Most vehicles registered outside of Area A used to commute to a work site located within Area A.

#### IF YOU LIVE AND WORK IN ARIZONA:

- Any vehicle you own and operate in Arizona must be registered in Arizona and display a valid Arizona license plate (some exceptions apply). For more information, please visit <u>azdot.gov/mvd</u> or contact the Arizona Department of Transportation (ADOT) Motor Vehicle Division at 602-255-0072.
- Any vehicle you use to drive to an Area A worksite is required to go through vehicle emissions testing. This applies even if you live outside of Area A.
- For employees who live outside of Area A, a proof of compliance form will be issued to you by the emissions testing facility at the time of emissions testing. Testing results, which are also sent electronically to ADOT, are needed for registration. After you submit your registration request, by mail or online, you will receive a registration tag for your license plate. For vehicles that are registered out-of-state (students/part-time employees) and that are parked on federal, state, or city parking properties, you will need to obtain an air quality compliance sticker for your driver's window from ADOT. - In addition to any other criminal penalty provided by law, a person who does not comply with this law is subject to a civil penalty of \$100 for a first violation and \$300 for a second violation.

Members of <u>Commuter Club</u> are eligible to join the fun and start redeeming their points for the chance to win a gift card! Here's how it works:

- 1. Log your alternate modes and collect your points.
- 2. Once you have at least 100 points, scroll to the bottom of your dashboard to your My Rewards section. Click on RideAmigos Sign Up and Trip Logging Points.
- 3. Under your points total, click on Show Details and Inventory.
- 4. The dashboard expands to show you the awards available to you and the points required to enter the drawing.
- 5. Click on the drawing you wish to enter. If you have the points available, you can redeem points for up to three entries. Example: If you have a points balance of 300 and each entry is 100 points, you can redeem the balance of your points for three drawing entries.

# Please review survey reports to track your agency's progress

The Annual Travel Reduction Survey is underway. Capitol Rideshare staff recently emailed the link to the training video and slide deck for implementing the 2023 Travel Reduction Survey. As noted in the training materials, staff will work with you to ensure you implement a successful survey at your agency. Staff sends daily reports to apprise you of your agency's progress toward meeting the state's 80 percent response rate goal. These reports help you determine who needs to complete a survey so you can tailor your outreach efforts to those employees and locations that have not returned the minimum number of surveys. Please review the reports and share them with your agencies' leadership if your agency is not reaching the minimum number of surveys at each mandatory reporting site. ## Emergency Ride Home: Don't wait for an emergency, sign up now for Commuter Club!

Employees who use an alternate mode at least twice per week—carpool, transit, telework, compressed work week, electric vehicle, biking or walking—are eligible for free membership in Commuter Club. The primary benefit of Commuter Club is to offer employees who use alternate modes of transportation an emergency ride home (ERH), up to twice per fiscal year, for unexpected emergencies. Examples of qualifying emergencies include medical emergency, family emergency or the commuter's carpool driver unexpectedly left early. Please note: you must have a Lyft account to self-dispatch the ERH; Capitol Rideshare provides a voucher credit to pay for up to \$50 for an emergency ride (this will not cover a driver tip). ## Reduce commute costs with Platinum Pass, free through June 30, 2023

Valley Metro buses and light rail can get you to work without the hassle of driving! Capitol Rideshare launched a pilot program offering a fully subsidized Platinum Pass through June 30, 2023. To sign up for the pass, please visit the Capitol Rideshare website to learn more about the program and download the application (applications should be returned to the employee's human resources contact for processing; Capitol Rideshare staff cannot process Platinum Pass applications). Please allow two weeks to receive the card, which is mailed to the employee's home address.

## West Phoenix High-Capacity Transit Study Public Meetings

Valley Metro and the City of Phoenix have initiated the West Phoenix High-capacity Transit Alternatives Analysis for the high-transit usage Maryvale area in west Phoenix. The study will identify a recommended route and type of high-capacity transit (bus rapid transit, streetcar or light rail transit) that will best meet the area's transportation needs. ## Employees must carpool three times/week to participate in the carpool program

Capitol Rideshare's <u>carpool program</u> rules state that employees who carpool at least three times per week are eligible for a Capitol Rideshare carpool parking permit. If you are working remotely and are no longer carpooling, please contact Capitol Rideshare staff via email at Rideshare-Help@azdoa.gov to cancel your parking permit.
