For state employees who live and work near transit routes, catching the bus or light rail might reduce your commute time and cost! Capitol Rideshare offers a transit subsidy to employees who sign up for the Platinum Pass; there is no fee to apply for the pass. The subsidy reduces the cost of transit usage to state employees. Visit the Capitol Rideshare website to learn more and to download the application.



### **CARPOOL**

Capitol Rideshare offers a preferential Rideshare parking permit to state employees in Maricopa County who carpool three or more days per week. This permit allows parking in reserved Rideshare spaces on the days that you carpool. Just go to the Capitol Rideshare website, complete an online application, and we will send you a permit to your office. Note: one permit is issued per carpool.





### **VANPOOL**

Vanpool may be an option for a larger group of employees (6-15) that live greater distances from their work sites. If you live at least 15 miles away from work, you are eligible to participate in a vanpool. Vanpool riders pay a monthly fee to cover the costs of operating the vehicle (fuel, insurance and maintenance). Capitol Rideshare will pay a monthly subsidy to cover the lease cost for each eligible state employee who participates in a qualifying vanpool. # RIDE-MATCHING SERVICES

For employees who are interested in carpooling or vanpooling but don't have a partner, Capitol Rideshare powered by RideAmigos offers a ride-matching service. Employees must use their work email addresses to create an account. Be sure to apply for your preferred parking permit when you have established your carpool (one permit per carpool). For vanpools, be sure to fill out the vanpool subsidy application at CapitolRideshare.az.gov once you have joined a vanpool.



### **ELECTRIC VEHICLES**

For state employees who have invested in electric vehicles (EV) or plug-in hybrid electric vehicles (PHEV), ChargePoint has multiple charging stations at (or near) many state worksites, including properties in the Capitol Mall area. Charging fees vary; fee information and charging station locations are available on the ChargePoint website, www.chargepoint.com. Employees driving zero-emission vehicles at least three times a week are eligible for a Capitol Rideshare parking permit.



### BIKING AND WALKING

If you live within a reasonable distance from your work site or transit stop, walking or cycling may be an option for you! The bike-on-transit program allows you to ride a bike to the transit stop, put your bike on the rack mounted on the bus and in the light rail cars and take transit to work. Capitol Rideshare has partnered with GRID Bike Share service to offer state employees a \$30 annual membership! ### **COMMUTER CLUB**

If you use one or more alternate modes at least twice a week (transit, carpool, telework, bike, walk, vanpool, compressed work week), you are eligible for Commuter Club membership powered by RideAmigos. Membership is available to non-university State of Arizona employees in Maricopa County. Benefits include a free emergency ride home from work through Lyft, trip planning options on the RideAmigos dashboard, trip logging to track money and pollution saved, and opportunities to win prizes! State employees can sign up for membership at CapitolRideshare.RideAmigos.com using their work email addresses.



### **RIDEAMIGOS**

Capitol Rideshare has launched an interactive commute solution on the RideAmigos transportation demand management (TDM) platform. State employees can sign up for an account at CapitolRideshare.RideAmigos.com. Employees must use their work email addresses to create an account. Your Capitol Rideshare RideAmigos account unlocks trip planning tools, commute tracking, contests and more! RideAmigos now powers several Capitol Rideshare programs, including Commuter Club, carpool parking and ride-matching services.
